LEAD AND ZINC MARKET FORECASTS

The outlook for world supply and demand for lead and zinc was presented during the ILZSG webmeetings held on 27 and 28 April 2021.

Lead Usage

After declining by 5.2% in 2020, global demand for refined lead metal was forecast to rise by 3.9% to 11.97 million tonnes in 2021.

Lead Supply

World lead mine supply and world refined lead metal supply were forecast to rise by 5.1% to 4.75 million tonnes and 3.3% to 12.07 million tonnes respectively in 2021.

World Refined Lead Metal Balance

The Group anticipated that the global supply of refined lead metal would exceed demand by 96,000 tonnes in 2021.

Zinc Usage

World demand for refined zinc metal was forecast to rise by 4.3% to 13.78 million tonnes in 2021, after falling by 3.9% in 2020.

Zinc Supply

A rise of 5.7% to 12.97 million tonnes and a rise of 3.1% to 14.13 million tonnes were forecast for global zinc mine and global refined zinc metal production respecitively in 2021.

World Refined Zinc Metal Balance

The Group anticipated that global supply for refined zinc metal would exceed demand by 353,000 tonnes in 2021.

COPPER MARKET FORECASTS

The world balance of refined copper production and usage was developed at the ICSG web-meetings held on 29-30 April 2021.

Copper Supply

After three years of remaining essentially unchanged, world copper mine production, adjusted for historical disruption factors, was expected to increase by 3.5% in 2021 and 3.7% in 2020. World refined copper production was expected to rise by 3%in both 2021 and 2022, following a 1.6% growth in 2020.

Copper Usage

World apparent refined copper usage in 2021 was expected to remain similar to that in 2020 and to grow by about 3% in 2022.

World Refined Copper Metal Balance

World refined copper balance projections indicated surpluses of about 80,000t in 2021 and 110,000t in 2022.

NICKEL MARKET FORECASTS

The INSG held its web-meetings on 23 and 26 April during which it developed its production and usage forecasts for world primary nickel.

Nickel Supply

World nickel mine production declined in 2020, mainly due to the Indonesian ban on exports of nickel ore. However, output was expected to recover in 2021. World primary nickel production was 2.494Mt in 2020 and was forecast to reach 2.718Mt in 2021.

Nickel Usage

World primary nickel usage was 2.386Mt in 2020. The INSG forecast an increase to 2.673Mt in 2021.

World Primary Nickel Balance

The Group anticipated surpluses of 108kt in 2020 and 45kt in 2021.




